## **Certificate in Accounting**

This course covers a broad range of core accounting skills, as well as accountancy-related business skills and personal skills. Key themes have also been introduced throughout the suite of accounting qualifications, including technology, ethics, sustainability, and communication.

This qualification comprises four mandatory units:

The four units are assessed individually through computer-based end-of-unit assessments.

## **Diploma in Accounting**

This qualification covers a range of essential and higher-level accounting techniques and disciplines. The qualification usually takes around one year to complete, but this will depend on study method and course timetable. It may be possible to complete it in as little as six months.

## **Diploma in Professional Accounting**

# Apprenticeship Courses







## What is an Apprenticeship?

Apprenticeships combine real work with training and study. Being an apprentice isn't the same as being a college or university student. You won't just study and gain new knowledge. As an apprentice, you'll be putting what you learn straight into practice. Apprentices don't have to pay tuition fees either.

#### As an apprentice you will:

- · Train for/in the workplace
- · Get hands-on experience
- Earn a salary and get the same rights as employees, including sick leave and holiday pay.
- Spend at least 20% of your working hours training or studying
- Undertake ongoing assessments, including an endpoint assessment

#### It can take between 1 and 2 years to complete an apprenticeship, depending on:

- · The apprenticeship you choose
- · Your apprenticeship level
- · Your previous experience



## **Accounting apprenticeships**

Training and retaining younger and less experienced members of the team can be a challenge for any organisation. By investing in an apprenticeship, a business can bring long-term benefits by building on existing knowledge and skills, improving performance, and boosting staff retention in junior and entry-level positions.

Apprentices will also develop business communications and lifelong learning skills, applying what they learn to the wider industry context.

## **Accounts / Finance Assistant**

An Accounts/Finance Assistant is an important part of the team, responsible for ensuring an efficient and accurate finance function within a business. This role is generally responsible for assisting the team of accountants with junior accounting duties. An apprentice's work at this level could include basic bookkeeping activities, working with sales and purchase ledgers, running calculations to make sure that records are correct, recording of cash and data entry. The role is not limited to practice accountancy and work in most industries or sector.

#### Programme Length: 12 months (+3 month EPA)

You must be employed full-time in a suitable position before commencing the programme. Course timetables and attendance requirements will be confirmed during your enrolment.

#### **Starting your Apprenticeship**

There are multiple start dates for your AAT studies, so enquiries are dealt with all year round. Candidates may start their employment at any time throughout the year, and work-based learning will start from day 1 of your employment. ## **Assistant Accountant**

The Diploma in Accounting qualification is at Level 3 – equivalent to A Levels – and will equip your team members with skills that can be directly applied within your organisation. An Assistant Accountant provides support to internal and external customers and will work predominantly either as an assistant accountant within practice or alternatively within the finance function of an organisation.

Part of the role will involve assisting in the day to day financial activities such as data entry to month end management accounts and/or year - end financial statements. In addition, the Assistant Accountant may find themselves involved in regulatory financial requirements, such as the completion of VAT returns or assisting in the preparation of tax computations.

#### Programme Length: 12 months (+3 month EPA)

Any existing knowledge will also be taken into account when deciding the duration of the programme.

You must be employed full-time in a suitable position before commencing the programme. Course timetables and attendance requirements will be confirmed during your enrolment.

## **Professional Accounting Technician**

The Professional Accounting Technician apprenticeship is a higher-level accounting qualification. You should possess either a Level 3 accounting qualification or have equivalent skills and knowledge through relevant and recent work experience. The programme helps you develop all the skills you will need to work in a modern accounting environment.

Completing the AAT Level 4 Diploma in Professional Accounting will make you eligible to apply for full AAT membership.

#### Programme Length: 15 months (+3 month EPA)

Any existing knowledge will also be considered when deciding the duration of the programme. You must be employed full-time in a suitable position before commencing the programme. Course timetables and attendance requirements will be confirmed during your enrolment.

#### **Starting your Apprenticeship**

With multiple start dates for your AAT studies, candidates may start their employment at any point. Work-based learning will start from day one. If you start your new role before your studies, one of the AAT assessor/coaching team can liaise with you over activities to undertake in the interim period.
